**CONTRACTOR REGISTRATION REQUIREMENTS**  
**CITY OF STERLING**

**REGISTRATION FEE**

*(if lapse occurs, termination is possible)*

\$50.00 Registration Fee to be paid one time only as long as a **current** Certificate of Insurance and a **current** License Bond Certificate are on file with the City.

**CERTIFICATE OF INSURANCE** (one copy)

*(current certificate must be submitted annually)*

Certificate of Insurance showing City of Sterling as certificate holder:

\$100,000/\$300,000 Public Liability or

\$50,000 Property Damage

\$10,000 Per Occurrence for “Home Repair/Remodel not in Conformance with Applicable Codes”

**Important Note: the *Certificate Holder* should say “City of Sterling/Building Department” with the above address**

**LICENSE BOND** (one copy)

*(must be renewed annually with continuation certificate)*

\$15,000 License Bond honoring the City of Sterling (**Plumber’s Are Exempt**)

(available through your insurance agent)

The City of Sterling will honor the \$45,000 License Bond honoring each of the cities (Rock Falls, Dixon, and Sterling) for \$15,000 each (available through your insurance agent)

**NOTE - Valid Licenses Required for:** Roofing and Plumbing (State of Illinois), and Electrical (Applicant shall have obtained a passing score upon a test administered to electrical registration in any city provided that the test taken was based upon the latest issue of the National Electrical Code in force at that time)
